1.0 Summary

The metronome trip for this year was focusing on the development of the coastal fisheries management plan from the community. The team spent the total days of 23 in the Central; team left Funafuti on the 16th of March and returned on the 10th of April. There were similar activities that have been on-going that was part of the trip. The total of Boat and Canoe that was surveyed were: Nui – 48; Nukufetau – 70; Vaitupu - 35. Ciguatera Fish Poisoning Case Update was none from all islands. Awareness programs were done in schools only. A refresher training for Data Collectors and feedbacks from each data collector. Post-harvest Training done in all islands – training of Community Fisheries Centre (CFC). Grab bag inspection from each island and the evaluation of the Grab bag condition. Maintenance of FADs in Vaitupu and evaluating the status of the FADs. An additional activity was added – LMMA Household Survey interviewing the community's point of view on Locally Managed Marine Area from their own island. In the community consultation, the goals in all islands were similar in wanting the improvement of their coastal fisheries resources. Each island have different approach on achieving the goal. There have been some feedbacks made from the community and Kaupule on how Fisheries could assist the island in various activities from the closing consultation (Day 3 of Developing Community Fisheries management Plan - Community Consultation & last day consultation with the kaupule).

2.0 Introduction

The team were funded by the Pacific Regional Oceanscape Project (PROP) and the Government of Tuvalu. These funds were used to support the program conducted in the Central islands; achieving the activities laid out in the tentative program.

The purpose of the mission to the central islands (Nui, Nukufetau and Vaitupu) was to consult with the Falekaupule and the communities in developing a new management plan that would focus solely on coastal fisheries related issues.

The team had other objectives planned during their stay in the central islands. Programs such as: Awareness Program (Community and School Awareness), Ciguatera Fish Poisoning Case update, Boat & Canoe Survey, LMMA Activities (Household Survey), Manta Tow in Nui, Post-harvest Activities and FADs maintenance.

The LMMA household survey was first carried out by Fisheries officers on three islands in the central Tuvalu which is Nui, Nukufetau and Vaitupu. This survey is to find out how much people know about the LMMA and also to find out from the people's perspective on how to improve lending of information about LMMA. In this survey, there are 30 people from each 3 islands that are randomly selected by TFD team to participate in this survey. The participants include children of 13 years old and above, youths, fishers, people in middle age and the old people.

Presentation briefly provided an overview of the Section activities to give a clear ideas to the participant on the important of the section to fishermen and each island CFC. And followed by a presentation on fish handling; the following is a short summary of the presentation content;

- ✓ What is fish spoilage
- ✓ What is the cause of fish spoilage
- ✓ Why is it important to handle fish properly

✓ Ways to preserve fish to maintain good quality of fish

The second presentation provided a refresher for CFC staff on the idea and concepts of fish preservation. The workshop training provided them with an idea of preserving our food. And also discussed on why it is important to preserve our fish as summarized below;

- o To maintain quality of fish (appearance, texture, flavor and nutritive value)
- To Protect food safety
- o To reduced losses between harvest and consumption
- o Introduced a trend of domestic trading.

Each CFC staff showed their interest and understand the different ways we can use to handle and preserve fish. And lastly, they understand the important as to why we need to handle fish properly and preserved them.

FAD's maintenance and monitoring was vital in assessing the condition of the FAD. Vaitupu was the only island in the central

3.0 Methodology

The arrangement with the central islands was prepared prior for the team's arrival. It was done by contacting the main person of each island in arranging the accommodation and needs for each island.

The team left Funafuti to Nui on the *LC Moeiteava* on the 16th of March and arrived on the 17th March. The *RV Talamoana* picked up the team from Nui on the 23rd of March and arrived in Nukufetau on the 24th of March. The *RV Talamoana* picked the team up from Nukufetau on the 1st of April and arrived in Vaitupu on the 2nd of April. The *RV Talamoana* then picked the team up from Vaitupu on the 9th of April and arrived in Funafuti on the 10th of April.

Consultation with the Kaupule; informing the Kaupule members on the tentative program and amending the changes in the time and day. Consultation with the Community, the presentation was made first to understand the concept the establishing of a coastal fisheries management plan. In activities section, the community was divided into 5 groups: Kaupule (and men), Elders, Fishermen Association, Women Association and Youth Association.

Selected number of presenters were presented in the school awareness on topics that relates to the coastal fisheries resources.

The Refresher training for Island Data Collector was done by arranging the time available for the Data Collector to visit the team.

The team members would visit to the medical center and discuss with the nurse on the positive cases of Ciguatera Fish Poisoning.

The team were divided into groups of two and the number within the group; it varies depending on the team members' time availability. The group would stroll around the island to find the boat or canoe then gets its measurements (measuring the length of the boat or canoe). Coordinates were recorded of where the boat or canoe was located using a GPS

The team from Resource Assessment and Monitoring sub-section made a trip around the lagoon and used the Manta Tow method in counting the invertebrates (Beche-de-mer or BDM).

For the LMMA Household Survey, the whole team was divided into two groups that would go to either one of the island communities side (Eg. Asau and Tumaseu in Vaitupu). Each group interviewed 15 participants from each side of the island community.

Post-harvest training was started off with Nui CFC on the 21st March 2022 to the 23rd March 2022, Nukufetau CFC started on the 29th March 2022 to 30th March 2022 and successfully ended with Vaitupu CFC on the 5th March 2022 to the 7th of March 2022. The training formally opened with a short summary and the benefits of the training. Then lastly, followed by a summary of the training expectations which included;

- I. CFC to produce healthy fish products;
- II. Improved knowledge on Fish Handling and processing;
- III. Improving opportunities for fish product marketing;
- IV. Improving trading of fish product between Tuvalu and the Pacific Islands;
- V. Understand different ways of preservation methods.

An inspection was carried out on the 19th March 2022, which was started with Nui, Nukufetau on the 31st March 2022 and successfully concluded with Vaitupu on the 8th March 2022. This is to effectively inspect each Grab Bags and to refresh each local fishers on the usage of each safety gears in the Grab Bag. This is one of the section priorities to ensure all fishers access to well-maintained safety equipment (Grab Bag) and at least inspected once in every year.

Prior to the team's departure, a final consultation was made to the Kaupule in summarizing the activities done in the island.

4.0 Results & Storage

4.1 Community Consultation

For this year's metronome trip, the community consultation was based on developing the Coastal Fisheries Management Plan. The island community was divided into groups with fisheries officers as facilitators for each group. The goals from all islands have shown similar goals but their goals and strategies were different in achieving the goals.

4.1.1 Nui Community Consultation

The consultation was held at *Manatu Mai Au* Falekaupule; commenced on the 18th of March then resumed the consultation on the 21st to the 22nd of March. The groups were divided into 5 groups: *Kaupule, Toeaina* (Elders), *Fishermen Association, Fafine* (Women Association), and *Malosiga* (Youth Group). The goal from all groups were similar as they want to *ensure that there is an improvement of coastal fisheries resources and supporting the livelihood of Nui community*. The attendance was great and have shown great interest in the developing of the plan. The community were more focused in getting the plan continuously operational in order to achieve some of the objectives to manage their coastal fisheries resources.

4.1.2 Nukufetau Community Consultation

The consultation was held at *Feagaimoteata* Falekaupule; commenced on the 25th of March then resumed on the 28th to the 29th of March. The groups were divided into 5 groups: *Kaupule, Toeaina* (Elders), *Fishermen Association, Fafine* (Women Association) and *Tamanuku* (Youth Group). The goal from all groups were similar as they focused on *improving the coastal fisheries resources in Nukufetau*. The attendance from the community was satisfactory as there were some community members were busy constructing the Tutasi Primary School. The community were more focused on strengthening the by-laws in managing the coastal fisheries resources.

4.1.3 Vaitupu Community Consultation

The consultation was held at *Anipule II* Falekaupule; commenced on the 5th of April to 7th of April. The groups were divided into 5 groups: *Kaupule & Men, Toeaina* (Elders), *Fishermen Association*, *Fafine* (Women Association) and *Lima Malosi* (Youth Group). The goals from all groups were similar as the community expected to have *an improvement of coastal fisheries resources in Vaitupu*. The attendance was great and have shown interest in the developing of the plan. The community were focused on the ecological point of view in dealing with the sediments found in the lagoon and ways to dredge the sediments out of the lagoon.

4.2 Ciguatera Fish Poisoning Case Update

In all islands from the Central, there was **no positive case** on Ciguatera Fish Poisoning.

4.3 Boat & canoe Survey

The team made a survey on locating boat and canoe and observe their conditions and location. Here are the tables from the central below:

From the above table, it shows that majority of the boat/canoe that was measured was the Aluminum Boat in Vaitupu.

4.4 LMMA Activities

4.4.1 Household Survey

The LMMA Officer conducted a survey with the help of the metronome team and the islands Community Fisheries Officer (CFO) and Data Collector (IDC). The survey was focused on:

- Participants who were fishers
- Heard of LMMA
- Knowledge of LMMA
- Knowledge of rules based on LMMA
- Penalties in placed
- Knowledge of LMMA Boundary
- Opening of LMMA

Here are the results from all islands from the Central.

4.4.1.1 Nui




Figure 1a above shows that most of the respondents were fishers. They mentioned that they mostly fished 2-4 times a week. Some of the participants used the catch for selling to support their families financially. Instead of selling their catch, they take them home for family consumption.




Figure 2a above shows the respondents heard on what LMMA was about. Most of them heard about the difference between the LMMA and MPA.




Figure 3a above shows that 64% respondents have knowledge of LMMA whereas 4% of the respondents have no knowledge of the LMMA. They have great knowledge on the reason why LMMA is established, its rules and guidelines, penalties and the LMMA boundary. Most people on the island claims that metronome trips have been the best way for them to earn about LMMA information. They recommended that this metronome trips to be continue as their way to receive LMMA related information.




Figure 4a above shows that 76% of the respondents have good knowledge of the rules in placed for the LMMA whereas 8% of the have a fair knowledge of the rules in placed. 16% of the respondents have shown that they do not about the rules in place. (Sentence for elaborating)




Figure 5a above shows that 76% of the respondents have good knowledge of the penalties whereas 4% of the respondents have a fair knowledge of the penalties in place.

There are 5 existing management measures on the island including no spear fishing, no diving of turtles, prohibit the use of fishing nets less than 2 inch in mash, prohibit the use of net fishing around patch reef in the lagoon and prohibit the use of scoop net ('lama) in the lagoon. Other than LMMA, MPA, Size limit and gear restriction, aquaculture was recommended by most of the 30 participant to be the main approach that help improve the management of coastal marine resources in Nui.




Figure 6a above shows that 64% of the respondents have good knowledge of the LMMA Boundary whereas 8% of the respondents have a fair knowledge of the LMMA Boundary.




Figure 7a shows that all of the respondents agreed that the LMMA was opened for fishing activities for special occasions. The 30 participants in this survey all agreed that the Falekaupule and its leaders have open the Nui LMMA in the past 2 years. Most of them argued that these areas were open twice a year and for 1 day only with limitation that equal to the use of fishing rod, hand line fishing (*Matau*, *Iafolafo*) and collecting of coconut crab and other crab species.

Other fishing methods still prohibited unless marine resources have been requested by the Nui community on Funafuti to provide catering on certain occasion hosted by the government. One of the reason the Nui Falekaupule open their LMMA is when the island community host a picnic for students and government officials who spend their holiday on the island.

Another reason is when government officials requested the Falekaupule and its leaders to visit these areas during their tour visit to Nui.

The main concerns over the past 2 years are coral bleaching, algal bloom and pollution. Nevertheless, Nui have a minor impact on decreasing in the coastal marine resources. The main species identified are Topsail (*Kyphosus Cinerascens*: *Nanue*), Bluestripe seaperch (*Lutjanus Kasmira*: *savane*), Humpback snapper (*Lutjanus gibbus: Taea*), Turtle (*Cheloniodea* sp.: *Fonu*), Sharpnose mullet (*Neomyxus chaptalii: Fuagutuloa*), Diamond scale mullet (*Liza vaiagiensis: Kafakafa*), Grouper (*gatala*), sea cucumber (Funafuna), Sipny rabbitfish (*Siganus spinus: maiava*), Convict surgeon fish (*Acanthurus triotegus: Manini*).

4.4.1.2 Nukufetau




Figure 1b above shows that 89% of 30 participants were fishers. They mostly fished 2-4 times per week. This survey shows that the average number of household of 30 participants is 7. Most of the participants are fishers. They usually went out fishing between 2-6 times per week. There are very few fishers who intend to sell their catch for income. Yet, the others have rely on marine resources for family consumption.




Figure 2b above shows the respondents view on the difference between LMMA and MPA and its function. 64% of the respondents understood on the differences between LMMA and MPA.







Figure above shows that the respondents view on understanding LMMA by looking at different settings of Objective, Rules, Penalties and Boundary. Quite a number of people involved in this survey have a great understanding of real reason for LMMA establishment, rules and guidelines, penalties for breaching the rules of the LMMA and the LMMA boundary.




People on the island have reported that metronome trips have been the best way for them to receive LMMA related information in the past.




The majority of them suggested that metronome trips to be continued as their main source of information regarding LMMA related matter; the most useful way to deliver LMMA information. Metronome is the best way for people to receive LMMA information.




The LMMA has been open by the island chief and the Falekaupule for fishing activities. It was advised that these areas have opened in 1-2 times a year and in a period of 1 day only when it is open. Reports from the people on the island that these areas are only permitted by the Chief and the Falekaupule when the island host a big ceremonial event. The Nukufetau community on Funafuti may request their main island for marine resources if they involved in catering of such event host by the government.



Most of the people on the island claims that during the open period of these LMMA, they found out that there is an increase in the sizes and quantity of fish caught by the community.



LMMA has the highest recommended approach to improve conservation of coastal resources. They recommended LMMA, Aquaculture, MPA, Size limit and gear restriction as approaches to improve the management of their marine resources.




Coral bleaching, pollution and decreasing of marine resources are the main concerns on the past 2 years.


The main species that are noted to be decreasing over the years are, Humpback snapper (*Lutjanus gibbus:* Taea), Bluestripe seaperch (*Lutjanus Kasmira: savane*), Sipny rabbitfish (*Siganus spinus: maiava*), Orange spine unicorn fish (*Naso lituratus: Umalei*), Diamond scale mullet (*Liza vaigiensis:*

Kafakafa), Topsail (Kyphosus cinerascens: Nanue), Tuna, Macakerel scad (Decapterus macarellus: Atule), Turtle (Cheloniodea sp.: Fonu)


4.4.1.3 Vaitupu



Most of the participants are fishers. They usually went out fishing between 2-6 times per week. There are very few fishers who intend to sell their catch for income. Yet, the others have rely on marine resources for family consumption.




The graph above shows that 51% percent of the respondents understood the difference between LMMA and MPA.




More than half of the people involved in this survey have heard of the LMMA, have good understanding of the rules of the LMMA, penalties for breaching the LMMA rules and good knowledge in the LMMA boundary.


However they have less knowledge in the difference between LMMA and MPA and the LMMA objectives.



The graph above shows how the respondents learn about LMMA. 41% of the respondents replied that metronome trips from fisheries team helped the community understand more on LMMA and its functions and impact towards the resources, environment and community.




It was reported that metronome trips have been the best way for people on the island to receive LMMA information and it also recommended by the island people to continue metronome trip as their best way to receive LMMA related information




More than half of the 30 participant confirmed that the Vaitupu LMMA have opened in the past 2 years. Mostly, these areas were opened between 1-3 times per year.


The island chief and the Falekaupule have allowed the island community to catch fish and crabs in these areas during bad weather were people hardly go out fishing in the open coastal areas. The other reason the island chief and the Falekaupule of Vaitupu open their LMMA for fishing activities in the past 2 years is that the Vaitupu community on the Capital requested their main island for marine resources for catering purposes in one of the event host by the government.



During the harvest of marine resources in the Vaitupu LMMA, most of the people noticed the increase in the sizes of fish and the amount caught by the community.



LMMA, Aquaculture, Size limit and gear restriction have been listed as approaches to improve the management of the Vaitupu coastal resources.



Pollution is the main concern over the past 2 years.

The main species that are noted to be decreasing are Surgeonfish (*Acanthurus lineatus: Ponelolo*), Vlaming's unicornfish (*Naso vlamingii: Pokapoka*), Sharpnose mullet (*Neomyxus chaptalii: Fuagutuloa*), Diamond scale mullet (*Liza vaiagiensis: Kafakafa*), Milk fish (*Chanos chanos: Paneava*), Slender keeltail needle *fish (Platybelone argalus: Ise)*, Convict surgeon fish (*Acanthurus triotegus: Manini*), Wahoo (*Acanthocybium solandri: Paala*).

4.5 Manta Tow Activity in Nui

The resource assessment and monitoring sub-section team and one officer from outer islands coastal management sub-section were involved in the survey in counting the population of the variety of beche-de-mer found in the Nui Lagoon. Nui was the last island to conduct the Manta tow survey within the lagoon. They covered the distance of 8.7 km covering the area of 87km².

Here are the counts below:

3.5a shows the sea cucumber species and the sample population of each species.

The above table shows that the species with the highest population is the Lollyfish (Holothuria atra).

4.6 Other Activities

4.6.1 Awareness Program

The team made a topic that was related to coastal fisheries resources. The topics covered were **Importance of FADS** presented by Pafini Fepuali, **Coral Reef Importance to Fishery** presented by Sione Falesene and **Size Limit** presented by Paeniu Lopati. It was only presented in schools as the community awareness was not set up due to community consultation.

In primary schools, the classes ranges from Class 6-8 students whereas in secondary school, the whole school was involved in the awareness program. There were pop quizzes made at the end of each presentation. For Motufoua Secondary School, the pop quiz was made and were given prize giveaways based on the presentation.

The Fisheries team presented the school incentive as a gift to the Primary Schools for senior classes.

There were some comments made from some staff based on the Awareness program.

NUI (VAIPUNA PRIMARY SCHOOL)

- Have posters and brochures that was similar to the topics presented.
- Animated videos based on the topics that would help students to be more attentive.

NUKUFETAU (TUTASI PRIMARY SCHOOL)

• Fortunate to have presenters to present topics that were relevant to coastal resources and ways to manage it when children grow up.

VAITUPU (TOLISE PRIMARY SCHOOL & MOTUFOUA SECONDARY SCHOOL)

• Found the topics useful for the students to understand about their coastal marine resources.

4.6.2 OIDC Refresher Training

A refresher training was made to refresh the practical of Creel Survey and ways to approach to Fishermen and/or locale(s). From that refresher, consultation was made to understand the issues that the data collector faced when doing his/her creel survey, liaising with the kaupule and/or report submission. Here are the issues and/or comments that the Data Collector faced.

NUI

- Wanted to have weighing scale and a portable printer
- Had issues on who was supposed to sign the fortnightly report before submitting the report.
- Communication challenges with the kaupule.

NUKUFETAU

 Creel Datasheet to be reviewed – some of the contents in the datasheet was deemed to be sensitive for fishers.

- Consider in creating the App that would link to the Fisheries MIS
- The Data Collector faced some issues with the fishers that refused to be surveyed.

VAITUPU

• Wanted to know the roles and responsibilities of a Community Fisheries Officer

4.7 Post-Harvest Training

The training was designed to support a sustainable development for small scale fisheries for livelihoods, food security and healthier diets. The Operation and Development unit was responsible for the organizing, planning and coordinating Post-Harvest Training to these 3 island CFC. PROP (Pacific Regional organization Project) provided immense support in funding training expenses for this training.

These pictures demonstrated the practical session in Nui CFC, Nukufetau CFC and Vaitupu CFC. The training focused only on CFC to provide and build their capacities on fish handling and processing. The training will provided them with good skills and knowledge on how to make use of our marine resources and possibly introduced a trend of trading in both domestic and international. This training will help each island communities in improving food security, economic growth and opportunities for employment for both young men and women.

Achievement and Outcome of the training

Each CFC training workshop was concluded with a recap from day 1 to day 3 and the important of hygienic in the workplace. Each participants was pleased with the training provided and provided positive feed backs as followed;

- ❖ Each participants acknowledge of receiving new information on the important of handling fish and also different techniques ingredients used for preservation.
- ❖ Each of them able to produced healthy dish products and understand the impact of hygienic in terms of fish handling and processing,
- The training provided with them skills and knowledge and increased their understanding ways to handle and process fish properly,
- The training also encourage them to produce fish product to make use of our marine resources which introduce a trend of domestic trading in both domestic and international,

Lastly, participants acknowledge that, they fully understand different preservation methods of preserving fish and also get to understand the important of those ingredients used in the preservation stage.

4.8 Sea Safety Training

This report will highlighted the inspection results from each island (Nui, Nukufetau and Vaitupu) in terms of their safety at sea. The training which included the following;

- 1. Refresher training on the usage of each gears and;
- 2. Inspection of the status of each Grab Bag;

Sea safety training was started off with a refresher training on how each fishers used single gears in the Grab Bag. A total number of 16 bag was donated to each island by the department and its development partners (NAPA II). Grab Bag inspection results were as follow below;

The table above showed the inspection results of these island (Nui, Nukufetau and Vaitupu). The inspections also found out that, some of the gears in the Grab Bags needed to be replace to ensure gears were all safe to use in any fishing incidents. The report also found out that,

handing over of Grab Bag to active fishermen caused the missing and loss of gears in any Grab Bags. It is highly recommended to work together the Fishermen association and the Kaupule in the management, monitoring on the wisely used of the Grab Bag.

4.9 FAD's Monitoring and Inspection

Vaitupu FADs deployed in the year 2017 around the 10th of June with FADs coordinate of (Latitude: 07"29.053'S / **Longitude: 178"39.847"E).** On the 4th of April 2022 an inspections to the FAD was carried out to inspect the status of the FAD. There were 4 officers of the TFD which included 3 officers from the Coastal division and 1 officer from Operation & Development division. The team inspected the main line of the FADs and the result turn out that the FADs was still in good condition. Lastly, the team aggregated the FADs with coconut leaves. This, will allowed small fish to protect themselves under those coconut leaves, which attracted big fish into the FAD.

5.0 Recommendations

There were some recommendations and points raised from the consultation (Kaupule and Community) on what they expect the team to raise it up with the head of section and/or senior administrators.

Also, the challenges that the team faced during the trip to the central and ways to solve the challenges in the upcoming trips.

Here are the points raised from the consultations in the Central islands:

NUI

- The community were concerned on the implementation phase of the management plan
 - If a back-up plan could be made that would relate to the strategies mentioned in the implementation and monitoring plan.
- The kaupule raised some points on:
 - o Possibility of deploying FADs in Nui by this year
 - Study on Brown Algae (*Sargassum sp.*) in certain areas/spot in Nui and possibility of fish getting *Gambierdiscus toxicus*.
 - Ways to recover the sea cucumber species' and Panea species population

NUKUFETAU

- The community were hoping to get the management plan get implemented before the change of kaupule members.
 - o Possibility of re-drafting the entire management plan.

- The kaupule raised some points on:
 - o Clarification of the Grab bags handling
 - o The effectiveness of LMMA and its contribution to the coastal fisheries resources

VAITUPU

- The community advised the team to ensure that the plan gets implemented to solve the sediment issue in the Vaitupu Lagoon.
- The community added on the concern about the developing of the Coastal Fisheries management Plan and which specific areas does the plan cover when looking at Coastal Fisheries.
- The Kaupule raised some points:
 - o Requesting assistance for freezers for catch storage
 - o Requesting assistance for a rug-like (strong grip) to prevent boats from slipping

Here are the points that the team faced during the metronome:

- Not enough days to get the activities done; most of the work was rushed
 - Extension of days would be needed in order to get the work done properly and get the team members enough rest for the upcoming activities.
- Laptops needed for the Fisheries Officers to type the activities done from the consultation (Developing of the Coastal Fisheries Management Plan)
- Need training for new appointed Data Collectors.
- The three islands have been receiving LMMA information during metronome trips. The island community have lived and seen the benefit of having a LMMA.
 - However, metronomes trips offers only 1 trip to a particular island per year and there is still a need of awareness program regarding LMMA related information.
 - It is highly recommended the use of other awareness methods such as posters and radio program to advocate the purpose and benefits of having an LMMA.
 - o Surveys should be done to monitor the decreasing of coastal marine resources.

 - He wondered about the Lollyfish including in the results
 - Maani answered that the BDM Survey was to count all BDM that the observer was able to see and record. He also mentioned that there was a way of doing a survey in Panea and BDM.
 - Paeniu added that that method was able to count any marine invertebrates.
 He mentioned that Nui was the last island to do conduct the survey.
- Aitopele asked on the VHF location and asked if it was possible to relocate and provide financial assistance
 - Pafini answered on what happened in the setting up of VHF and also was unaware about that issue. He mentioned that there's another type of VHF (Landbased VHF)

 - Paeniu answered on what he witnessed. He mentioned that the seaweed (Sargassum) was an invasive species and also it would grow rapidly in any conditions.

 - A Kaupule member mentioned on the seaweed and where it appeared in some parts of Nui's coastal areas.
 - Maani commented on the point "Is there a way to eradicate seaweed completely?" He mentioned that it's hard to determine as it grows rapidly in any conditions.
 - Paeniu recalled on the survey done in 2011 where they focus in seaweed and how it would be helpful. He mentioned the symptoms of seaweed having GTOX like itching when bathing in the sea and contributes ciguatoxin in fish that contribute to CFP.
 - Kaupule thinks that that seaweed need to be extracted out.
 - Aitopele asked on what "lailai" means that contributes to CTX?
 - Paeniu answered that he was referring to sewage effluent that it was found from bottomless septic tank.
 - o Maselusi asked on the lollyfish and if they play an important role.
 - Maani answered that sea cucumber plays an important role in filtering sediments to become finer and also helps with the aeration.


