### **Position summary:**

Under the supervision of the SFO Outer Islands, the LMMA Officer works with all outer island Kaupule to determine required fisheries management support and advice on LMMAs. He/She will be primarily responsible for managing community-based fisheries LMMA activities under the coastal section annual work plan.

#### Main responsibilities:

The LMMA officer will monitor work progress, ensure timely delivery of outputs as indicated in each island community-based fisheries management plan. This also includes facilitation of community consultation, carrying out surveys, monitoring of each LMMA on the outer islands. He/She will assist in leading fisheries staff on the implementation of each fisheries regular visit to the outer islands through each metronome trip.

### Main duties:

- Consult with the SFO Resource Assessment & Monitoring and other member of the Coastal Fisheries section in order to determine fishery monitoring and research needs
- Facilitating the implementation activities related to data collection and strengthening of LMMAs/MPAs (marine protected areas)
- In collaboration with SFO Outer Islands, assist the PFO Coastal in formulating Annual Work Plans and quarterly activity plans
- Carry out a baseline assessment survey for each LMMAs and to verify the baseline status
- Assist the SFO Outer Islands in operationalising an M&E plan for each LMMA
- Produce trip reports after each metronome trip to the outer islands
- Work with coastal division staffs in carrying out continuous creel surveys in outer islands
- Assist island communities in carrying out and compiling data from creel surveys
- Work with coastal staffs in organising local consultations for activities related to establishing and strengthening LMMAs/MPAs
- Assist the SFO Outer Islands in organising community awareness meetings and workshops, national events
- Contribute to progress reports to PFO Coastal on a quarterly basis
- Assist the SFO Outer islands in producing articles and other outreach/knowledge materials based on the AWP
- Manage relationships with project stakeholders including donors, NGOs, communities, community representatives, government agencies, and others as required

- Produce a self-assessment at the end of each year against agreed targets for a performance review
- Participate in field surveys and data collection activities in Funafuti and in the outer islands as required
- Assist with the delivery of analysis of monitoring and research data
