Position summary:

The Principal Fisheries Officer – Oceanic Fisheries is a senior management position working under the Managing Director and the senior management team in ensuring the Fisheries Department Corporate Plan and Budget is successfully implemented and managed. The PFO – Oceanic Fisheries has responsibility to oversee the four work areas of the Oceanic Section – licensing, VMS & VDS, the observer programme; and compliance and enforcement. The PFO is expected to provide leadership and guidance to Oceanic section personnel in meeting the objectives of work that is essential for delivering sustainable benefits from the nation's tuna resources.

Main responsibilities:

- Responsible for overseeing the implementation and execution of all the Oceanic Section's Licensing, VMS and VDS, Observer Programme and Compliance and Enforcement activities
- Lead, motivate and manage the performance of all Oceanic Fisheries personnel
- Plan and co-ordinate human resource development for all Staff (including temporary workers) in collaboration with the Human Resources Manager and Deputy Director (Corporate)
- Provide accurate information, analysis and advice on purse seine and longline tuna fisheries matters and policy
- Ensure the effective implementation the Fisheries Department Corporate Plan that relate to the operations of the Oceanic fisheries operations and deliver accurate and timely reporting against Budget and Corporate Plan
- Ensure the efficient maintenance and use of all plant, equipment and materials under the Oceanic section
- Provide well-researched and strategically sound representation for Tuvalu in regional or subregional fisheries forums where necessary
- Undertake other duties as directed by the Managing Director

Special conditions:

- Regular out-of-hours work as well as international travel will be required to successfully carry out the position's duties
- Assist in representing the interests of Tuvalu though participation at regional and international forums relevant to Tuvalu Fisheries
- Undertake any professional development required to ensure currency on all matters relating to fisheries both at a national, sub-regional, regional and international level
